1. Background on CRAWN Trust

CRAWN Trust is a women led non-state actor established in 2010 and registered as a Trust corporation (ps2000). The organisation aims to promote citizen's awareness of their human rights and non- discrimination of women, in the political, social, economic and cultural spheres of development as enshrined in the constitution of Kenya 2020 from a gender perspective. The organization's mission is to promote values-led leadership and governance that supports the full enjoyment of social, economic, and political rights. CRAWN Trust believes transformative change is possible through an informed and empowered citizenry driving equity, justice, inclusivity, and sustainability.

2. About the Green Champions for Change (GCC) Project

CRAWN Trust is implementing the Green Champions for Change (GCC) Project, a project funded by Akina Mama wa Afrika (AMwA). The project has been working to strengthen the participation and leadership of women and other marginalized groups in climate governance processes, aiming to influence climate policy, practice, and budgeting through feminist, rights-based, and intersectional approaches.

The GCC project builds on existing climate justice efforts by identifying, training, and supporting grassroots women-led movements and green champions to take active roles in climate governance. It also ensures that gender-responsive and eco-friendly local solutions are documented and used to shape national and local-level decision-making.

The GCC Project contributes to feminist climate justice by amplifying the voices of grassroots women, supporting inclusive advocacy networks, and integrating feminist principles in environmental governance. As part of its commitment to learning and accountability, CRAWN Trust is undertaking a robust MEAL process to document outcomes, assess change, and enhance programming.

3. Purpose of the MEAL Consultancy

The purpose of this consultancy is to support CRAWN Trust in strengthening Monitoring, Evaluation, Accountability, and Learning (MEAL) systems under the GCC project, with a



focus on Outcome Harvesting. The consultant will work closely with project teams and stakeholders to document key outcomes, assess the project's contribution to change, and provide evidence-based recommendations to inform future programming.

4. Objectives of the Consultancy

The key objectives of the consultancy are to:

- Conduct an Outcome Harvesting process to identify, verify, and analyze significant changes resulting from the GCC Project.
- Assess project relevance, effectiveness, and sustainability from a feminist climate justice lens.
- Facilitate participatory learning sessions with CRAWN staff and stakeholders.
- Produce a comprehensive MEAL report capturing qualitative and quantitative results, success stories, and strategic insights.
- Provide actionable recommendations to strengthen CRAWN Trust's programming

5. Scope of Work

The consultant will:

- 1. Participate in an inception meeting with CRAWN Trust to clarify scope and expectations.
- 2. Develop and share an inception report including an Outcome Harvesting methodology and tools tailored to the GCC context.

- 7. Facilitate a validation workshop with CRAWN Trust and selected stakeholders.
- 8. Produce a final MEAL report with a summary of findings, outcomes, analysis, lessons learned, and recommendations.
- 9. Deliver a simplified learning brief or presentation for internal and external use.

- Advanced degree in Social Sciences, Development Studies, M&E, or related field with 3 years' experience or Bachelor's Degree with at least 5 years experience.
